**PLAINTIFFS’ MOTION FOR AWARD OF ATTORNEYS’
FEES, COSTS, AND INCENTIVE AWARDS
TO CLASS REPRESENTATIVES**

Through undersigned counsel, Plaintiffs Brooke Ryan and Christina Fusca (collectively, “Plaintiffs” or “Class Representatives”) respectfully move this Court for approval of reasonable attorneys’ fees, costs, and incentive awards to Class Representatives pursuant to the proposed Class Action Settlement Agreement that this Court preliminarily approved in its Order dated October 15, 2024. Plaintiffs move for an award of attorneys’ fees in the amount of \$2,300,000 and litigation expenses in the amount of \$30,527.91 with such amounts to be paid from the Settlement Fund in accordance with the terms of the Settlement. Plaintiffs additionally move for incentive awards to the Class Representatives in the amount of \$5,000 each. In further support of
